Exceptional Digital Meeting of the Board of Directors | May 13, 2020 - 10:00am Location On-line

I. Welcome/Introductions.

- **a.** The WRAC Board conducted its regular monthly meeting on-line video and audio on April 2, 2020, Chair Maryam Zar called the meeting to order and began introductions at approximately 10:00 a.m.
- **b. Representatives Participating**: Robin Greenberg (BABCNC;); Larry Watts (BCC); Matt Wersinger (DRNC); Andrew Lewis (NWWNC); Chris Spitz (PPCC); Ira Koslow (VNC); Paula Gerez (NCWP); Jane Wishon (WNC).

IV. Member Updates.

- a. Member Greenberg announced the BABCNC is sponsoring a blood drive
- **b.** Member Koslow discussed the need for a procedure for censuring unacceptable and disruptive behavior.

- c. Member Spitz described a PPCC/BCC Meals for Heroes program providing UCLA MC, Santa Monica Hosp. ER; St. John's Hosp., LAFD and LAPD. She also commented on the need for a bylaws amendment to provide for virtual meetings.
- **d.** The Chair discussed a WRAC platform addressing foundational principles for administrative issues as distinguished from policy positions. This would require a bylaws amendment.

V. Presentation.

- **a.** The Chair introduced Jackie Koci Tamayo and Aram Sahakian form the LA Dept. of Emergency Management who gave a lengthy presentation concerning the City's response to the COVID pandemic. Some of the information included the following .
 - i. A level I was activated on March 6, 2020 with about 150 people staffing each operations center, many working remotely and supporting many missions.
 - ii. Thirty-three testing sites, including a mega-site at Dodger Stadium have been established.
 - iii. To date four childcare centers have been established for first reponders, with more to follow.
 - iv. An extensive Q & A followed their presentation.

WHEREAS, prior to the Covid 19 Emergency, Neighborhood and Community Councils served as the only notice to the general community of planning projects and due to the current Covid 19 Public Health Emergency, NCs and CCs have not been able to establish credited virtual meetings where the outcomes of discussion and Community Impact Statements are affirmatively recognized by the City and the Department of Neighborhood Empowerment.
 - ii. THEREFORE, BE IT RESOLVED that the ------ NC/CC requests that the L.A. Dept. of City Planning, City Planning Commission and Area Planning Commissions cease all discretionary approvals until such a time as all Neighborhood Councils, Community Councils, The City Planning Commission, Area Planning Commissions and the Dept. of City Planning Itself have established adequate measures to ensure full public participation and access to Hearings and Documents
