- Denny. Another LAX expansion is coming. They want to add 2 more terminals and
make changes to the north runway. They want to fix the way the planes leave from the
runway to the taxiway. It will be less safe. There is an MOU limiting them to 153 gates
and this is being ignored. The MOU expires in 2024. They want to leave 3 of the

Western remote gates open. The MOU closes them. They want concourse 0 to the east of terminal 1. Terminal 9 will be on the east side of Sepulveda. They want to add 12-18 gates. Comments are due on the 15th. Information from DOT is not forthcoming. Go to <https://www.lawa.org/ATMP> to read about the terminal modernization project. They are planning to accommodate 128 million passengers. Mike Bonin supports the residents. The airport is not being responsive to him. Their excuse is the Olympics, but this could have been handled in other ways.

Barbara. Ontario is doing better since they left LAWA. Can we use this? Denny. They don't have a plan. The automated people mover won't handle the number of people they are planning.
