**Re: Conditions at Los Angeles City animal shelters; CF #s 24-0304 and 23-0193; support all actions necessary to end mistreatment of animals, including development of a plan for action to improve management and operations at City animal shelters.**

Dear Mayor Bass, Council President Krekorian and Councilmembers Blumenfield, McOsker, Hernandez, Park, Yaroslavsky, Raman and Hutt:

The Westside Regional Alliance of Councils (WRAC) is a cooperative coalition of all 14 neighborhood and community councils on the Westside of Los Angeles.

In light of recent serious concerns about the continuing deplorable conditions at the City's animal shelters, e.g., <https://abc7.com/some-animal-advocates-decry-shelter-crisis-city-of-los-angeles-approves-motion-aimed-at-increasing-staffing/14530005/>, we now reiterate WRAC's position expressed in December 2022, strongly supporting the goals and requests made by Bel Air Beverly Crest Neighborhood Council to end mistreatment of animals at City shelters: <https://westsidecouncils.com/wp-content/uploads/2022/08/WRAC-letter-re-Animal-Shelter-Conditions.pdf>.

We note that the City Council has recently passed a motion for more funding for Animal Services (CF 23-0193/Hernandez); we also note the recent Animal Services report (CF 24-0304), calling for emergency funding for that department (matter assigned to the BFC and PAHC and now pending in these committees).

While WRAC's member councils have not taken positions specific to these Council Files, based on our past position decrying the conditions in City animal shelters, we respectfully urge the City Council and relevant Council Committees *as soon as possible* to take all actions necessary to ensure the ethical treatment and safety of animals in these shelters, including not only funding for more staffing, but developing a much-needed ***plan for action to improve management and operations at the shelters so that mistreatment of animals will at long last come to an end.***
