In case you missed it, here's an update on our February 20, 2023 WRAC Board meeting.

Presidents' Day: Robin remarked on the significance and history of the day.

Government Reports:

The Board was honored to welcome our guest speaker, **Assemblymember Jacqui Irwin** (AD 42 – representing Pacific Palisades, Brentwood, Bel-Air Beverly Crest & a portion of Westwood/Westwood Hills). She related her background in local and state government (including her years as Mayor of Thousand Oaks, which informs her support for local control over zoning decisions); provided information about her policies, plans and concerns (including possible legislation to amend SB 9 to exempt areas in the VHFHSZ from additional density); introduced her staff in attendance (Deputy District Director Nancy Frawley and Field Representative Skylar Payab); and explained that she and her staff are excited to be learning more about the new communities she now represents on the Westside. An extensive and informative Q&A with board members then ensued. We thank Asm. Irwin for speaking with us on Presidents' Day and look forward to working with her in the months and years ahead.

We also had an important presentation by LADWP representatives Clint Kautsky (Civil Engineer) and Deborah Hong (Community Liaison), who discussed the concerning proposal before the State Water Resources Control Board to **restrict LADWP's water rights in the Mono Basin.** They maintained that there is no emergency to justify prohibiting LADWP from exercising its long-held water rights. LADWP now encourages all member Councils and stakeholders to submit written comment opposing the proposal, which Mr. Kautsky explained will have significant consequences (including rate increases) for Los Angeles ratepayers if the Water Board approves the proposal; comment submission deadline **March 17.** Submit comments to monolake@waterboards.ca.gov. In addition, we heard informative reports and updates from additional government representatives: Jake Ettinger (District Representative for Sen. Ben Allen); Michael Amster (Field Deputy for CM Traci Park); and Veronica de la Cruz-Robles (Neighborhood Prosecutor).

We look forward to the Roundtable with CM Park this coming Monday – *the first in-person WRAC meeting in three years!*

Next Board Meeting: March 13. As noted, our guest speaker will be Asm. Chavez Zbur; we will also have an update on the Sepulveda Transit Corridor project by Yusef Robb of TK Communications. The Board decided to postpone our June 19th meeting (the Juneteenth holiday) to **June 26, 2023**; other upcoming 2023 Board meeting dates will remain as scheduled.

WRAC Committees:

The Board heard reports and updates from WRAC standing committee chairs on the work of their respective committees: Selena Inouye (WRAC MTC), Judie Hewlett (WRAC PSEPC) and Jay Handal (WRAC HOC).

New & Pending Motions:

The board passed two new WRAC-recommended motions: (1) Request re RSO Housing Replacements, and (2) Request for STAP program audit. The passage deadline was extended to March for one pending motion: Venice Blvd. Improvements Project Concerns/Withhold Support.
