Currently, we find ourselves in a unique situation regarding the Metro TCN program. We believe it is crucial to ensure that our community has ample time and opportunities for public outreach and input on this matter.

Digital billboards are a serious matter in our city. In the past the MVCC has opposed such projects.

As the changing display currently stands, it poses a significant distraction to drivers, making the situation potentially hazardous. It is imperative that the city provides us with the necessary time to thoroughly evaluate this program.

Therefore, we respectfully request that the City Planning Commission (CPC) hearing scheduled for September 14, 2023, be postponed.
