In case you missed it, here's an update on our October 30, 2023 WRAC Board meeting.

Guest Speaker:

We were honored to hear from **Capt. III Richard Gabaldon**, Commanding Officer of LAPD West LA Division. The Captain briefed us on his background, reported on the state of crime and the challenges of policing in the largest division in the City, and answered board member questions. Government Reports:

We were pleased to be introduced to Mayor Bass's *new* West Area Representative, Marian Ensley, who reported on several of the Mayor's recent initiatives, including successful engagement with unhoused individuals and encampment removals on the Westside under the Inside Safe program (*e.g.*, removal of the longstanding huge encampment under the 405 along Venice Blvd. in Mar Vista/CD 11 and a portion of CD 5), as well as a new Mayor's directive to reduce wait times for 3-1-1 requests. We thank all the government reps for attending and keeping us updated.

 - 1) Letter to Mayor and City Officials re Removal of Transportation Commission President (10/30 agenda item 7a);
 - 2) PRA Request to LAHSA for information on entities operating housing/shelter facilities under Inside Safe (10/30 agenda item 7b).

The #1 letter will be sent shortly; the #2 request has been sent (note: LAHSA's response will be due before the next HOC meeting on 11/28).
