### Item 6:

Although LAHSA has previously reported on Point in Time (PIT) figures for communities, it did not do so in the last PIT count (reporting only on total figures for Service Planning Areas, e.g. SPA Area 5 for the Westside, but not for individual neighborhoods within the SPA area). CD 11 Homelessness Director Juan Fregoso (now District Director) has indicated that his office is asking LAHSA to publish these figures (status unknown as of 1/05/24)

**Note:** Per CM Park, 41.18 (c)(1) is currently interpreted to apply only to *encampments* in the public right of way, not to vehicle dwelling (*see also Item 8, CM Park oversized vehicle dwelling motion*)
