## Re: OPPOSE LA Metro Congestion Pricing on the Westside Without Robust Transit Options in Place

Dear Ms. Wiggins, Mayor Bass, Supervisor Horvath, Councilmembers Harris-Dawson, Yaroslavsky and Park, Mr. Vallianatos and Ms. Litvak:

The Westside Regional Alliance of Councils (WRAC) is a cooperative coalition of all 14 neighborhood and community councils on the Westside of Los Angeles, in Council Districts 5 and 11 and portions of Council Districts 4 and 10. Our Alliance represents over 500,000 Angelenos.

Many of WRAC's member councils have expressed concern that LA Metro may implement congestion pricing strategies along key Westside routes – the I-405 and I-10 freeways – before robust public transit options are actually in place and their impacts are fully experienced and assessed. Concerns that have been expressed include: the fact that congestion pricing may disproportionately impact lower income individuals who must drive yet cannot afford to live where a car-free or transit only commute is possible; the likelihood of drivers using alternate routes through nearby local streets to avoid paying the charge, thus increasing traffic congestion on local roadways in nearby neighborhoods and in many cases (along the 405) on narrow hillside streets; and the potential for exacerbating already difficult emergency evacuation during dangerous wildfire events in our Very High Fire Hazard Zone areas with limited means of ingress and egress (including in Bel Air Beverly Crest, Brentwood and Pacific Palisades).

Our members have also noted that according to news reports, a proposal for congestion pricing in New York City (a metropolitan area with long-established, robust transit options, unliked the Westside of Los Angeles) has *been postponed indefinitely*.

As a result, a majority (8) of WRAC's member councils have passed the following motion, or modified versions in keeping with its spirit: <sup>1</sup>

"The Westside Regional Alliance of Councils (WRAC) strongly opposes the implementation of Metro's Congestion Pricing pilot (aka the Metro Traffic Reductions Study (TRS) project) without first having robust transit options in place in the North/South direction through the Sepulveda Pass from the 101 to the 10 freeway.

"Robust transit options are defined as either 1) enhanced bus service through the Sepulveda Pass as previously suggested by the Southern California Association of Governments (<u>https://scag.ca.gov/sites/main/files/file-attachments/mobilitygozone report final.pdf?1604269434</u>) and 2) the Sepulveda Transit Corridor project, which will provide either monorail or heavy rail subway service from the San Fernando Valley to LAX, with a stop on the UCLA Campus."<sup>2</sup>

We therefore respectfully urge LA Metro to decline to implement the TRS project (the Westside congestion pricing pilot) at this time, unless and until robust transit options are in place, as requested in the above motion.
