Government Reports:

New & Pending Motions

-- **New Motions:** The Board passed a motion to *Oppose CF 21-0329-S5 (Yaroslavsky) & Support LAMC Sec. 41.18* – item 7 on the 6/17/24 agenda. See the text and details about the motion at:

-- **Passed and Pending Motions:** One motion has now been passed by a majority (8) of WRAC Member Councils and is now an adopted WRAC position: *Oppose Congestion Pricing without Robust Transit Options in Place*. Please let us know by June 20 if you have considered and voted to oppose this motion.

One motion remains pending, with the passage deadline now extended to August 2024 (*Cap on Waivers for ED1/Streamlining Ordinance Projects*). This motion has passed to date in six Member Councils; only two more councils are needed in order for the motion to become an adopted WRAC position.
