Background – "Incomplete/Abandoned Construction" motion (proposed by Chris Spitz/PPCC, Robin Greenberg/BABCNC, Terri Tippit/WNC)

Proposed Motion Text:

"I	NC/CC, a member of the Westside Regional Alliance of Councils, believes that there is a
clear n	need for oversight and accountability for negligent property owners and developers who
allow	construction sites to remain incomplete and/or abandoned for extended time periods.
N	NC/CC therefore supports CF 24-1128 (Hernandez), which calls for a report back by LADBS
on con	sequences and solutions to the problem of abandoned / incomplete construction."

Over the years, neighborhoods represented by WRAC members councils, including BABCNC, PPCC and WNC, have experienced incomplete or abandoned construction projects which present clear threats to public health and safety. These sites are nuisances and magnets for squatters, contribute to blight and are at constant risk of fire, with resulting potential serious property damage and even loss of life.

The risk of fire at abandoned construction sites is particularly acute in Pacific Palisades, Brentwood and Bel Air-Beverly Crest, which are either substantially or entirely located within the designated Very High Fire Hazard Severity Zone (VHFHSZ).

In 2021, WRAC adopted a position in support of an earlier motion in City Council calling for a report on enforcement remedies, such as completion bonds, for unfinished construction; see: https://westsidecouncils.com/wp-content/uploads/2020/10/WRAC-Unifinished-Developments.pdf. That Council File (CF 20-1174) was never taken up in Council and eventually expired in 2022.

Based on our experience with abandoned / incomplete construction projects and WRAC's past support for a report on enforcement remedies for such projects, the motion spponsors accordingly recommend that the WRAC Board approve of the above proposed motion for recommendation to WRAC member councils -- supporting CF 24-1128, which calls for a report by LADBS on the consequences and solutions to the problem of abandoned / incomplete construction.
